How to Sign your Waiver:

- 1 Click on link to open waiver page
- 2 Fill in your own personal information (the first page is your information not your child's).
- Where it says "Do you need to check-in any minors under 18 years old?", Select "Yes"
- 4 Click "next".
- 5 Fill in your first child's information
- 6 Where it says "Are you, [Your Name], participating?",
 - select "Yes" if you are personally doing an activity at WildPlay with your child's group
 - select "No" if you are signing the waiver for your child to do an activity.
- 7 If you have another child select "Add Another Minor", if you do not, select "Next"
- 8 A list of activities will appear. Select the activity your child is participating in.
- 9 After reading the agreement, click "I agree to these terms".
- 10 Read the second page and click, "I agree to these terms" again.
- 11 On the third page provide an electronic signature and select "Submit".

And you're done!

FAQs

My waiver has multiple time slots and/or activities to choose from, what do I choose? You can choose any time slot or activity when signing your waiver, as long as you choose at least one!

Are there access requirements for the courses?

Yes! More information can be found on our website, wildplay.com, but the most important access requirement for our most popular activities is HEIGHT!

Participants must be: 3'9" to experience the Kids Course or 4'8" to experience the Classic and Extreme Courses!

Does my child need to wear anything specific?

Yes! Make sure your child is wearing clothing that is comfortable and easy to move in, tie back long hair, and be wearing closed-toed shoes that are securely attached to the foot.
