# RESOLUTION APPOINTING ANDES CENTRAL SCHOOL DISTRICT AS LEAD AGENCY AND ISSUING NEGATIVE DECLARATION FOR THE ANDES CENTRAL SCHOOL DISTRICT STREAM CORRIDOR RESTORATION PROJECT

WHEREAS, the Andes Central School District is considering undertaking reconstruction of the waterways, Liddle Brook and Tremperskill, including relocation of existing utilities, replacement of a vehicular bridge and necessary sitework to accomplish such work (hereinafter referred to as the "proposed project"); and

WHEREAS, the proposed project requires compliance with the provisions of the Environmental Conservation Law of the State of New York and the regulations of the Department of Environmental Conservation, Part 617, State Environmental Quality Review Act; and

WHEREAS, the Board of Education for the Andes Central School District is required to review the proposed project in accordance with the regulations of the New York

State Environmental Quality Review Act (hereinafter "SEQRA"), Part 617, and the Environmental Conservation Law of the State of New York; and

WHEREAS, the Board of Education has previously adopted a resolution declaring its intent to act as lead agency in a coordinated review with the Involved Agencies and Interested Agencies for the review of plans and environmental impact, if any, of the proposed project; and

WHEREAS, the Involved Agencies and Interested Agencies have been informed of the adoption by the Board of Education of the Andes Central School District of its resolution dated March 23, 2023, in which the Board of Education declared its intent to serve as Lead Agency in a coordinated manner with the Involved Agencies and Interested Agencies; and

WHEREAS, the Involved Agencies and Interested Agencies have either consented to the Board of Education of the Andes Central School District acting as the Lead Agency for this proposed project or have not responded within the required time frame to object to the Lead Agency designation by the Board of Education of the South Colonie Central School District.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. The Board of Education of the Andes Central School District shall be the lead agency for the proposed project.
- 2. After conducting a thorough environmental review, in accordance with SEQRA, the Board of Education of the Andes Central School District determines that the previously described proposed project is a Type 1 Action and will not result in any significant adverse environmental impacts; the Superintendent of Schools for the Andes Central School District Education is authorized to execute the Environmental Assessment Form, (hereinafter the "EAF", and a copy of which is attached hereto) with respect to the proposed project will not result in any significant adverse environmental impacts and no potential significant adverse environmental impacts are known.
- 3. The Clerk of the Board of Education of the Andes Central School District is hereby directed to cause to be filed and circulated the negative declaration in accordance with the requirements of SEQRA, a copy of the negative declaration shall be maintained in the office of the Clerk of the Board of Education of the South Colonie Central School District in a file that will be readily accessible to the public, and the clerk shall mail copies, return receipt requested to:
