"This expiration date is tentative and conditional only. Except to the extent required by the applicable provisions of Section 3012 of the Education Law, in order to be granted tenure the teacher must receive composite or overall annual professional performance review ratings pursuant to Section 3012-c and/or 3012-d of the Education Law of either effective or highly effective in at least three (3) of the four (4) preceding years, and if the teacher receives an ineffective composite or overall rating in the final year of the probationary period the teacher shall not be eligible for tenure at that time. Salary pending the completion of the Andes Faculty Association negotiations. M/C 5-0

Motion by Jason Mondore, seconded by Karen Bornarth to approve the Andes Central School out of district tuition rate, effective 2024-2025 school year, \$1000 per student per year in attendance. 50% of the tuition would be due no later than September 30, 2024 with the remaining 50% due no later than January 1, 2025. There will be a grandfather clause where all current out of district students, will continue to pay the tuition set forth from the year they started their enrollment in the school. Each family, starting with the 2024-25 school year, that will have one or more additional children enroll in the school, will receive a 10% discount per child. M/C 5-0
